I. School Responsibilities

Lincoln School Will:

1. Provide high-quality curriculum and instruction in a supportive and effective learning environment that enables the participating children to meet the State's student academic achievement standards as follows:
 - *Aligning all curriculum to New Jersey Student Learning Standards(NJSLS)*
 - *Using research-based programs and practices*
 - *Assessing students using data and adjusting instruction as needed*
 - *Creating a school-based committee to reinforce a positive school climate.*
 - *Ensuring all teachers are trained on state mandates*
 - *Checking all teachers are Highly Qualified to teach given area*
 - *Providing teachers with professional development on effective strategies, classroom management, state testing and other assessments*
 - *Creating report cards which align to NJSLS and are disseminated to parents three times a year*
2. Hold parent-teacher conferences during which this compact will be discussed as it relates to the individual child's achievement.
 - *Conferences are held once each school year*
 - *Parents may request a conference at any time*
3. Provide parents with frequent reports on their children's progress. Specifically, the school will provide reports as follows:
 - *Progress Reports are sent home to those in need in October, January and April*
 - *Report Cards are sent home in December, March and June*
4. Provide parents reasonable access to staff. Specifically, staff will be available for consultation with parents as follows:
 - *Parents may request a conference at any time by calling the main office at 201-438-7675 ext 6218 or emailing the teacher*
 - *Response To Intervention (RTI) committee meetings*
 - *Teacher and Administrative representative attend PTA meetings*
5. Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities, as follows:

- *Parents are invited to visit the classroom during special Star Student, Mystery Reader programs and planned visitations*
- *Parents encouraged to join the PTA and volunteer for holiday parties, classroom activities, fund raising, lunch distribution, Field Day, etc.*
- *Parents visit the PTA website for a list of volunteer opportunities*

II Parent Responsibilities

We, as parents, will support our children's learning in the following ways:

- *Limiting absences to sickness, religious observances, Bring Child to Work Day, participation in legal matters and Board of Education Election activity (see Student Handbook)*
- *Having children arrive to school on time*
- *Making sure that homework is completed*
- *Monitoring number of television/ videos my children watch*
- *Participating, as appropriate, in decisions relating to my children's education*
- *Promoting positive use of my child's extracurricular time*
- *Staying informed about my child's education and communicating with the school by promptly reading all notices from the school or the school district either received by my child or by mail and responding, as appropriate*

- *Checking children eat healthy foods, get adequate rest, and maintain positive social connections*
